ICT Acceptable Use Agreement

Please read and discuss this agreement with your child so everyone understands the expectations. Access to Information and Communication Technologies at St Clare of Assisi is a privilege that depends on following these practices.

Using a school provided device is a privilege. I must follow the conditions below to ensure the safety, privacy, and respectful use of technology for myself and others.

I will:

- Use any device for educational purposes only and only as directed by my teacher.
- Follow teacher instructions about when and how the device may be used.
- Use only the school's Wi-Fi and follow all security settings, firewalls, and filtering systems.
- Keep my passwords private and secure.
- Respect others' privacy by using only my own accounts and files.
- Report any technical issues, damage, or suspicious activity to a teacher immediately.
- Handle any device carefully, carry it safety and securely when moving, and store it safely when not in use.
- Keep food and drink away from the device.
- Use respectful and appropriate language in all online communication including messages, chats and posts.
- Follow the school's behaviour expectations when using technology.

I will not:

- Use any device before or after school, during recess or lunch without teacher permission.
- Access, download, or share inappropriate content, including violent, explicit, or offensive material.
- Attempt to bypass security settings, firewalls, or filtering systems.
- Hack, gain unauthorised access to networks, or interfere with other people's accounts or devices.
- Take photos, videos, or recordings of others without their permission.
- Take or share photos, videos, or recordings of school grounds, staff, or students in uniform.
- Share personal information online (full name, address, phone number, passwords).
- Engage in cyberbullying, including sending or sharing harmful or unkind messages.
- Play games or access social media unless explicitly permitted for a learning task.
- Install or modify software, apps, or settings without school approval.
- Tamper with or damage any device.

Teacher and School Authority

- Teachers and school staff may check files, browsing history, or device use at any time if there are concerns about misuse.
- Only authorised school staff may install or approve software and extensions.

Breaking the Agreement

If I break this agreement, the school may:

- Withdraw the school provided device or network privileges for a period of time.
- Notify my parents or carers.
- Provide guidance from the ICT Coordinator or School Executive on safer practices.
- Apply further consequences as outlined in the School Behaviour Management Policy, including meetings with parents or suspension of technology privileges for repeated or serious breaches.

Parent/Carer Acknowledgement

In supporting my child's use of a school-provided device, I:

- Understand that devices are school property and are intended for use at school unless specific arrangements are made.
- Acknowledge that the use of any school provided device is subject to staff direction and that failure to follow instructions may result in the consequences above.
- Support the school in reinforcing safe, responsible, and respectful device use.
- Consent to my child's use of school-approved apps, software, and online tools (e.g., Google Workspace, Canva) for educational purposes.
- Understand that some data (e.g., Google Workspace accounts) may be stored or processed on secure servers outside Australia in compliance with relevant data protection policies.
